

NARRATIVE

UNIT #2, A GOLD 2009 TOYOTA RAV4, WAS EAST ON E SILVER ST STOPPED AT THE STOP SIGN AT MOUND ST. PREPARING TO TURN RIGHT. UNIT #1, A MAROON 1999 FORD TAURUS WAS ALSO TRAVELLING EAST ON E SILVER ST APPROACHING THE SAME INTERSECTION. IT APPEARS THE DRIVER OF UNIT #1 SUFFERED A MEDICAL CONDITION THAT PREVENTED HER FROM BEING ABLE TO PROPERLY MAINTAIN CONTROL OF HER VEHICLE AND SLAMMED INTO THE REAR OF UNIT #2 CAUSING MAJOR DAMAGE TO BOTH VEHICLES AFTER THE HARD COLLISION. UNIT #1 THEN CONTINUED OFF UNIT #2 GOING ACROSS MOUND ST. OFF ROAD, AND INTO A BRICK BARRI.


